**Hi CRYC Members,** Your Membership for the year 1st April 2026 to 31st March 2027 is now due.

We ask Members to apply for **Renewal** of their **Membership** ASAP and certainly no later than **30th April 2026**.

If CRYC is your Primary Club the fee is \$60, if CRYC is not your Primary Club the fee is \$50. For each additional direct family member, the fee is \$20. The Primary Club Fee and Additional Family member fees include QRYA insurance of \$15.

Please note you will only be eligible to attend and partake at the 2027 AGM once your membership is renewed. Technically if you have failed to renew you will be ineligible to take part in Club sailing events.

**Members are respectfully reminded of the undertakings they gave initially when applying for their membership. Members are asked to take an active role in volunteering to assist the CRYC in - setting up and dismantling equipment, hosting events and having fun at our sailing sessions.**
